

## OFFICIAL RULES FOR “Share It Auto Club Speedway Latino – Dale Gasolina Sweepstakes”

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING**

**SWEEPSTAKES PERIOD:** “Share It Auto Club Speedway Latino -- Dale Gasolina Sweepstakes” (“Sweepstakes”) begins on January 23, 2016 at 12:01 a.m. Pacific Standard Time (“PST”) and ends on January 23, 2017 at 11:59 p.m. PST (the “Sweepstakes Period”).

**HOW TO ENTER:** Once a month during the Sweepstakes Period, Auto Club Speedway will share or retweet on their social media platforms of Facebook, Twitter or Instagram. During the Sweepstakes Period, there are three (3) ways to enter: “Share” on the designated post (“Entry Post”) on Auto Club Speedway’s Facebook page, <https://www.facebook.com/DaleGasolina> or “Retweet” on the designated tweet (“Entry Tweet”) on Auto Club Speedway’s Twitter page, <https://twitter.com/dalegasolina> or “Comment or Repost” on the designated post (“Entry Post”) on Auto Club Speedway’s Instagram page, <https://www.instagram.com/dalegasolina/> and be automatically entered into the Sweepstakes. Entries generated by script, macro or other automated or mechanical means or by any means which subvert the entry process are void. Limit one (1) entry per person, per day. Entries received from any person in excess of the limitation will be void. All entries become the sole property of the Sponsor and will not be returned. Fraudulent entries will be void.
